12.22.11	<p>Stitch counts for size 42 $\frac{3}{4}$" / 108.5 cm (5th size) have been revised for the Front:</p> <p>On page 2, middle column, in the 3rd paragraph under Front, the 3rd line should begin: "Work 13 (14, 16, 20, 26, 24, 25, 24, 25, 30) sts, pm...."</p> <p>On page 2, right column, the 5th paragraph should begin: "Move cable panel one st to the left every 8 (6, 6, 6, 6, 6, 4, 4, 4, 4) rows 4 (8, 9, 6, 11, 1, 16, 11, 10, 10) times, then every 6 (4, 4, 4, 0, 4, 2, 2, 2, 2) rows 4 (3, 2, 7, 0, 15, 2, 12, 15, 15) times...."</p>
06.19.13	<p>Page 4 - In the left column, the last line should end: "...ending with a WS row."</p> <p>Page 4 - In the middle column, the first line should begin: "Next row (RS):".</p>
09.16.13	<p>Page 2 - In the middle column, the third paragraph under Front has been changed:</p> <p>Continue as established until Hem Cable Chart is complete. On your last RS row, mark cable panel as follows: Work 14 (14, 14, 24, 26, 24, 25, 24, 24, 25) sts, pm, work 18 sts, pm, work to end. On your next row, evenly decrease 11 (16, 20, 14, 19, 22, 23, 26, 27, 35) sts from the section before the first marker and 4 (3, 0, 9, 5, 5, 5, 5, 4, 1) st(s) from the section after the second marker to accommodate the</p>

difference in gauge from the Hem Cable to St st: 72 (80, 86, 92, 100,
106, 112, 120, 126, 134) sts rem.
